

# Full House Lottery 2010

## Rules and Regulations

### Draw Dates:

#### Loyalty Prize Draw

- 3 prizes: \$5,000 cash, trip for two to Paris, France and a trip for two to Manzanillo, Mexico.
- Sales Deadline – Midnight, April 14, 2010.
- Draw – April 27, 2010, 11:00 am at Calder Bateman Communications Ltd.

#### Early Bird Prize Draw

- 1 prize: Osoyoos Vacation Home
- Sales Deadline – Midnight, June 3, 2010
- Draw – June 23, 2010, 11:00 am at Calder Bateman Communications Ltd.

#### Final Prize Draw

- Sales Deadline – Midnight, June 24, 2010
- Draws – July 19 through July 23, 2010, 9am – 5pm daily at Grant MacEwan University.
- Final Live Draw (all three Dream Homes) – July 26, 2010, 6pm at 4019 Whispering River Dr, Windermere North, SW Edmonton – Draw Order: Manhattan, Wellington II, Debussy.

In the event that all tickets are sold by midnight on June 3, 2010, all remaining draws will begin (with approval of the AGLC) on June 23, 2010, at the Grant MacEwan University, 10700 104 Ave, Edmonton, Alberta, Canada, T5J 4S2. The draw will run June 23 through until July 5, 2010 with the final live draws being held at 4019 Whispering River Dr, Windermere North on July 6, 2010 at 6pm – Draw Order: Manhattan, Wellington II, Debussy.

#### Draw Order:

After the Loyalty and Early Bird Prize draws, the draw order shall begin on July 19, 2010, with the lowest value prize drawn first and proceed further in reverse order with the Grand Prize Dream Homes drawn last. After each winner is recorded, the stub is returned to the drum. Ticket buyers are eligible for all 6,290 prizes.

#### Notification:

Stride Management will contact all winners in writing following the final draw. All winners' names will be published on the Full House Lottery website.

#### Prizes:

All 6,290 prizes, including Dream Homes, must be accepted as awarded; no substitutes. All prizes must be claimed within one year of the prize draws, except for vacation packages, which must be booked within one year of the draws, unless the supplier agrees to otherwise. Full House Lottery and its suppliers are not responsible for any costs incurred to pick up prizes. The winners are responsible for all shipping costs if they choose to have their prizes shipped to them. All vacations, except where noted, are

provided by Marlin Travel and include airfare and accommodation for two. You must be 18 years or older to purchase a ticket. Ticket sellers will advise all adult ticket buyers not to write the name of a person under the age of 18 on a ticket due to the Public Trustee Act.

**(47,178 single \$100 tickets, 20,706 sets of 3 for \$250, 3,932 sets of 5 for \$375 and 3,538 sets of 8 for \$525)**

Retail value of all prizes: approx. \$6,462,000 (including GST).

The minimum number of tickets to be sold prior to requesting a draw date extension or cancellation of the lottery is 118,779 (74% of total ticket value).

Any refund requests will be individually investigated. After determining the validity of the request, the official ticket number will be cancelled and a refund cheque issued within 24 hours of the decision to refund.
